MA candidates register their thesis topics after successfully passing at least 50% of the courses with the grade (Very Good). Then, they submit proposals to the department to be forwarded to the faculty council if accepted and to the deanship of higher studies.

2. Scientific Supervision:

Professors, Associate Professors or Assistant Professors with a two-year tenure track who already published two research articles in specialized refereed journals can supervise graduate students theses. The Saudi Universities Regulations apply.

1. The program holds an orientation day every year for new students at the beginning of the first semester explain the rules and regulations of the university and the program.

help them solve their academic problems if any. The academic guide explains and follows up the study plan of students.

- 3- Instructors are required to announce their office hours and ensure that their students are aware of that.
- 4- The academic counseling committee comprises specialized sub-committees dedicated to social, vocational, and psychological guidance, ensuring that students receive comprehensive support that addresses their academic, personal, and career-related needs..

4. Special Support:

- 1- The program has a postgraduate committee that has developed a clear mechanism for identifying low achievers, students with disabilities, and talented and gifted students. Once these groups are identified, tailored support plans and specialized programs are designed and implemented to address their specific academic needs, enhance their strengths, and ensure equitable learning opportunities for all students.
- 2- Classroom activities are structured in a way to help both the gifted students and the low achievers. The disabled students could be helped through the services provided by the university and the college.
- 3- Talented and creative students are honored in a ceremony held within the college.
- 4- Low-achieving students are provided with additional academic activities and targeted support to help them improve their performance, develop effective learning strategies, and successfully manage and achieve the required learning goals.
